FLIGHT TRAINING AND CERTIFICATIONS

OSU flight training for professional pilot students includes Federal Aviation Administration (FAA) certification with courses offered in private, instrument, commercial, multiengine and certified flight instructor (CFI). The Ray and Linda Booker OSU Flight Center is an approved FAA Part 141 and Restricted ATP program.

IMPORTANT DATES FOR THE PROFESSIONAL PILOT PROGRAM Students can apply for admission at apply.okstate.edu after their junior year of high school. July 1st Students can apply for admission using the Common App. Aug. 1st Aerospace Administration and Operations should be selected for the major interest. Nov. 1st Secondary Application for Professional Pilot is due. Dec. 1st Enrollment Deposit begins. Professional Pilot selected and waitlists announced. Jan. 1st Flight Account Deposit due for those selected for the program. Feb. 1st Waitlist acceptance due for those offered a spot on the waitlist. Housing, Orientation and Enrollment selection due. May 1st
